The Board of Trustees, of the Town of Hayti, South Dakota, met on Monday, Dec. 16, 6:30 p.m. at the City Office. Members present were Debra Goebel, Jeremy Struckman, Greg Biederstedt, Matt Miller and Dylan Reuer.

Chairwoman Debra Goebel called the meeting to order.

The Pledge of Allegiance was said.

Public Comment:

Biederstedt made a motion to approve the agenda; seconded by Miller. Minutes of the previous meeting of Nov. 13, 2024 were read. Struckman made a motion to approve the minutes, Reuer seconded. All voted in favor, the motion passed.

Motion by Miller, seconded by Struckman, to approve the monthly financial report; all voted in favor, the motion carried.

John & Chelsie Gustafson discussed the progress in regards to opening a golf simulator in the former Training Room.

The gym will be used by shooting sports Jan. - March/April.

Santa Day is Dec. 18, 5 – 7 pm at the Hayti Fire Hall.

The Watertown landfill informed Bass Sanitation they were raising the fees to dump garbage. This means that each resident in Hayti will see a higher garbage fee beginning Jan. 1<sup>st</sup>, 2025. Garbage rates will increase from \$21.50 to \$28.00. Biederstedt made a motion to continue using Bass Sanitation for garbage service,

Struckman seconded the motion. All voted in favor, motion passed. Miller made a motion to increase the sewer rate by \$1.50, to \$17.00, seconded by Reuer. All voted in favor, motion passed. The minimum due for water/sewer/garbage/water tower will be \$80.00; an increase of \$8 each month.

Once again OtterTail will be sponsoring a lighting contest in Hayti. Three winners will be selected.

The Town of Hayti has an active Economic Development Board; to streamline funds for their projects, and on recommendation from the city attorney, Hayti will adopt a similar way of giving the board funds, for the growth of Hayti, as other local communities. Council agreed to appropriate \$60,000.00 each year to the Economic Development Board, a supplement to the 2025 appropriations will be done.

Miller made a motion to go into Executive Session, for personnel reasons, at 7:30 p.m., seconded by Struckman. All voted in favor, motion passed. Biederstedt made a motion to come out of executive session at 7:34 p.m., seconded by Miller. All voted in favor, motion passed. Struckman made a motion to approve a Christmas bonus for employees, Biederstedt seconded the motion. All voted in favor, Reuer abstained, motion passed.

The next regular meeting is set for Wednesday, January 8, 2025; 6:30 p.m. at the City Finance Office.

There being no further business, motion by Miller; seconded by Reuer to adjourn. All voted in favor, the meeting adjourned.
