Reuer made a motion to accept the Internal Audit Review, seconded by Miller. All voted in favor, motion passed.

Providing all accounts are paid up to date, Reuer made a motion, seconded by Biederstedt to approve the annual Malt Beverage License for Renegades. All voted in favor, motion passed.

Biederstedt made a motion, seconded by Reuer to approve the annual Malt Beverage License for El Rapidito. All voted in favor, motion passed.

Discussion was held on the old school gym. Council members are looking for public input about what to do with the building. May 19th, 7:00 p.m., a community public meeting will be held in the Hayti Fire Hall. Everyone is invited to attend.

The dump will be open Weds. April 16, 23, and 30; 4:00 pm – 8:00 pm. No Saturdays until May due to lack of staffing.
