Chairwoman Debra Goebel called the meeting to order.

Public Comment:

Gramberg made a motion to approve the agenda; seconded by Swenson.

Sioux Rural Water notified the town that the rates will be raised again in 2026. This is the 6th rate increase in 6 years. The rates for water have not been increased since 2021. Struckman made a motion to raise the base fee from \$25 to \$30, seconded by Gramberg. All voted in favor, motion passed. An ordinance reading will follow at the next meeting.

Struckman made a motion to come out of executive session at 7:13 pm, seconded by Gramberg. All voted in favor, motion passed.

There being no further business, motion by Swenson; seconded by Struckman to adjourn. All voted in favor, the meeting adjourned.
