September 10, 2025

The Board of Trustees, of the Town of Hayti, South Dakota, met on Wed., Sept. 10, 6:30 p.m. at the City Office. Members present were Debra Goebel, Jeremy Struckman, Dylan Reuer, Jeremiah Gramberg, and Cody Swenson.

Others attending: Loren Seppanen, Jenna Aderhold.

Chairwoman Debra Goebel called the meeting to order.

The Pledge of Allegiance was said.

Public Comment:

Speed change on Highway 21 and Drainage Study were added to the agenda. Struckman made a motion to approve the agenda; seconded by Gramberg.

Minutes of the previous meeting of August 11, 2025 were read. Struckman made a motion to approve the minutes, Reuer seconded. All voted in favor, the motion passed.

Motion by Swenson, seconded by Gramberg, to approve the monthly financial report; all voted in favor, the motion carried.

Balance on hand in each fund as of August 31, 2025 are: General Fund, \$263,085.62; General Fund assigned to Street Improvement, \$71,765.24; Water Fund, \$119,570.16; Water Deposit Fund, \$1,700.00; Sewer Fund, \$110,180.25; Total of all funds: \$566,301.27.

Police Report:

Corwin's Report: Replaced a hydrant, fixed water leak on Charger Ave., and all the speed limit, no through trucks, and stop signs have been installed on the north side of town. A dump roll off will be rented for the landfill for Hayti residents fall clean up, no curbside pick up will happen in the fall.

Struckman made a motion, seconded by Reuer, to approve the Fee Schedule for the Town of Hayti. All voted in favor, motion passed.

The park committee will meet on Sept. 22nd, 7:30 p.m. Discussion on a water feature at the new park was discussed; council members do not support a water feature at the park.

Struckman made a motion, seconded by Swenson, to waive the Peddlers License fee for Bun on the Run for Homecoming Day. All voted in favor, motion passed.

Joanne Amundson has requested a water refund for over payment the last 15 years. Council tabled the decision pending discussion with the state legislative audit and legal counsel.

Loren Seppanen asked council exactly what land, how much square footage on the lot, would go with the gym. A couple parties are interested and because of zoning regulations regarding square footage and required parking spaces, this needs to be defined. Council members looked at the map and figured out what could be included in the gym acquisition. Swenson will talk to the Hamlin School Board; to see if land to the east of the basketball court could be included. Ideas for the gym are for a multi unit apartment or a church.

2nd reading Ordinance #335 2026 Appropriation was held. Reuer made a motion to approve Ordinance #335 – 2026 Appropriation, seconded by Struckman. All voted in favor, motion passed.

2nd reading Ordinance #336 Amend Ordinance 256 - An Ordinance to set the number of On and Off sale Liquor Licenses was held. Swenson made a motion to approve Ordinance #336, seconded by Gramberg. All voted in favor, motion passed.

The SD Dept. of Transportation notified the Town of Hayti of a speed limit change on Highway 21. Heading east on Redbird Ave., the 25 mph will be extended to 1,600 feet (from 900 feet) then east 1,000 feet, 45 mph.

The suggested fix for drainage issues in Hayti would be curb and gutter. DANR does help communities with legal paperwork for a grant or low interest loan. Mason, at First District, will be contacted for more information.

A letter, being sent to a resident who brought a shipping container into Hayti for storage, was reviewed by council. The decision by the Zoning Administrave Official, Carol Reuer, that this type of storage unit is not allowed in Hayti, per the Zoning Ordinance. Council members concur with this decision.

The next regular meeting is set for Wednesday, October 8, 2025; 6:30 p.m. at the City Finance Office.

There being no further business, motion by Reuer; seconded by Gramberg to adjourn. All voted in favor, the meeting adjourned.
